Electrical Specification Deviation Errata of FT90x

3.1 Revision B

3.1.1 FSOURCE Pin issue

Introduction:

The FT90x series has dedicated VPP and FSOURCE input pins as 64-bit EFUESE program source inputs. The function of VPP and FSOURCE pins provide the program indicate voltage (VPP = ± 1.85 V, FSOURCE = +3.70V Typical) while 64-bit EFUSE burnt on-going. Otherwise, keeps FSOURCE pin floating or tiers to ground for EFUSE read operation or standby mode.

Issue:

The FSOURCE pin has an issue that it doesn't support EFUSE programming on the FT90x series Revision

Workaround:

There is no workaround for this revision, will try to be fixed on next version.

Hardware reference design:

1) No need change any PCB design. Keep original design for next fixed version to drop-in.




Figure 1 Package Markings - FT90XQ 100-pin




Figure 2 Package Markings - FT90XL 100-pin






Figure 3 Package Markings - FT90XQ 76-pin




Figure 4 Package Markings - FT90XL 80-pin
